

The Role of the Procedural Advocate

The role of the Procedural Advocate is to help you understand the conduct process, make decisions about how to respond to any alleged charges regarding violations of the Code of Student Conduct, and provide you with support before, during, or after any pre-hearings or hearings.

If you as a student have filed a complaint against another student, you are also entitled to a procedural advocate.

Procedural advocates can be any trained member of the Utica College Community.

Procedural Advocate 101

How to Request a Procedural Advocate

If you are interested in having a procedural advocate, you need to work with your Hearing Officer. The Hearing Officer that is hearing your case will provide you with the contact information for a trained procedural advocate. Although your Hearing Officer will contact the procedural advocate you've selected, ultimately it is up to you to contact the procedural advocate you've selected to set up an appointment, discuss next steps, and address how to move forward.

Procedural Advocate Do's and Don'ts

DO-

- *Be honest with your procedural advocate
- *Respect your procedural advocate's time
- *Contact your procedural advocate and set up a time to meet with them **before** your hearing
- *Listen to what your procedural advocate has to say

DON'T-

- *Disregard the advice you receive from your procedural advocate
- *Show up late or cancel meetings with your procedural advocate at the last minute
- *Expect your Procedural Advocate to speak for you
- *Disregard your responsibility and accountability for the situation
